

DECLARATION OF CONFORMITY MAGNESIUM PRODUCTS

The original declaration of conformity is written in spanish, in case of doubt read in the original language.

In accordance with the document received, shown in the Annex, Aludesign S.p.A., as a company, declare that:

We know and take responsibility for the terms of the previous directives and regulations.

As mentioned in the Quality Certificate of Raw Materials, **QT006D**, the Magnesium carbonate used in the manufacture of our products comply with the directive ISO 9001:2015, as certified by AFAQ (n° 1998/9297.6). Our Magnesium carbonate is approved for use in food, according to the European Commission Regulation n° 231/2012, to E504 (ii), thus it is free of any Heavy Metal.

Values below the following limits: [Pb] < 3ppm, [Cd] < 1 ppm, [Hg] < 0,1 ppm and [As] < 2 ppm.

- Our raw materials don't contain any of the substances listed neither in UE Regulation 850/2004 nor in REACH and ROHS, as shown in the analysis.
- Alcohol is listed in Proposition 65 in terms of Alcoholic beverages, nevertheless our products are not produced for that purpose.
- The analysis of Magnesium carbonate is certified by SCORA S.A., we can provide those certificates if needed.
- The analysis of Alcohol made by SIMAR S.A. is certified according to ISO 9001:2015.
- The analysis of Rosin made by PINO PINE S.A. is certified according to ISO 9001 and is REACH compliant.

In relation to the 94/62/EC directive we are aware, as far as we know, that our suppliers meet the directive in terms of heavy metals concentration in the packaging.


DECLARATION OF CONFORMITY MAGNESIUM PRODUCTS
